LITTLE CANADA KIT LIST

The children must have *one* item of luggage (preferably a rucksack) containing their bedding, clothing and other essentials. We recommend that all items are labelled with the child's name and school.

Bedding

- Sleeping bag
- Pillow with pillow case

Clothing

- Warm night clothes
- Several changes of underwear
- At least two thick jumpers/fleeces/Hordle Hoodie
- At least three pairs of old trousers (two for activities and one for evenings; jeans are impractical as they provide no warmth when wet and are difficult to dry and leggings are not warm enough)
- Shorts
- Several t-shirts (long and short sleeved**some activities dictate that you have to wear long sleeves*)
- Several pairs of socks
- At least two pairs of trainers/outdoor shoes (including one pair that could be used for wet and/or muddy activities)
- Waterproof jacket with hood
- Swimwear
- One set of evening clothes for the disco (no high heels)

Other essentials

- Labelled strong plastic bags for laundry and wet clothes
- Refillable plastic bottle for water
- Sun hat and sun lotion
- Wash bag and contents (roll-on rather than aerosol deodorants as these can set off fire alarms)
- At least two towels (for swimming/wet activities and for use in their room)

Children may also wish to bring a reading book or puzzle book for quiet times. If they want to bring a camera this will be their responsibility and it must be named.

They are not permitted to bring mobile phones or any other electronic equipment such as hairdryers, MP3 players, hand-held games etc.

Pocket money up to the value of £10.00 (change preferable for budgeting) may be brought in a named purse, which will be looked after by an adult.
